## **NOTIFICATION 12 OF 2020**

Sub: Grant of additional attempt to the students of various Diploma Programmes.

Ref: An Extra Ordinary Board Meeting dated 9<sup>th</sup> October 2020.

Students of 2011, 2012, 2013 and 2014 batch under 03 years Diploma Programmes, students of 2009, 2010, 2011 & 2012 batch under 04 years Diploma Programmes and students of 2011 batch under 03<sup>1</sup>/<sub>2</sub> years Diploma Programme, had requested to grant additional attempt/s for completion of their Diploma Programme. Board in its meeting held on 9<sup>th</sup> October 2020 deliberated on the issue and it was decided as follows:-

- Decision 1.1: Students of 2011 batch (03 year) with 04 or less number of Courses pending completion of Diploma are granted one additional attempt i.e. Nov 2020 Board Examinations, to complete their Diploma Programmes, failing which they stand exited from the System.
- Decision 1.2: Students of 2012 batch (03 year) are granted a Special Mercy attempt i.e. November 2020 Board Examination, to complete their Diploma Programmes, failing which they stand exited from the System.
- Decision 1.3: Students of 2013 batch (03 year) are granted one Mercy attempt i.e. November 2020 Board Examination, to complete their Diploma Programmes, failing which they stand exited from the System.



- Decision 1.4: Students of 2014 batch (03 year) are granted two additional attempts i.e. Nov 2020 & April 2021 Board Examinations, to complete their Diploma Programmes, failing which they stand exited from the System.
- Decision 1.5: Students of 2009 batch (04 year) with 04 or less number of Courses pending completion of Diploma are granted one additional attempt i.e. Nov 2020 Board Examination, failing which they stand exited from the System.
- <u>Decision 1.6</u>: Students of 2010 batch (04 year) are granted a Special Mercy attempt i.e. November 2020 Board Examination, to complete their Diploma Programmes, failing which they stand exited from the System.
- Decision 1.7: Students of 2011 batch (04 year) are granted one Mercy attempt i.e. November 2020 Board Examination, to complete their Diploma Programmes, failing which they stand exited from the System.
  - Decision 1.8: Students of 2012 batch (04 year) are granted two additional attempts i.e. Nov 2020 & April 2021 Board Examinations, to complete their Diploma Programmes, failing which they stand exited from the System.
- Decision 1.9: Students of 2011 batch (3½ year) are granted a Special mercy attempt i.e. November 2020 Board Examination, to complete their Diploma Programmes, failing which they stand exited from the System.
